40 children interested in playing basketball. Could field a Varsity and JV boys and JV girls teams. Would need to work to fill the Varsity girls team; ~2 players now. Registration was due on October 24<sup>th</sup>. Reaching out to CYO president for support

Fee are up for discussion because of the exchange of money prior to and during games is an issue. Might need to increase the registration fee to cover the cost of the Ref fees which are ~\$35. Current fee per child is \$90. Donations might be another operation. Need to make sure the fee cost will not be a deterrent for the children to join.
