776 Dinners sold on first Friday; \$8,800 in sales. Understaffed on skilled side (fryers or oven). Challenges with the parking lot. Difficulty finding people parked in the parking lot. Plan to power cook a lot of fish. Serious updates on the fulfillment, steam table, shrimp and parking lot management. At 3:30 - 40 orders due a 4 am. By 3:50 the line was out past Common Street. Finding people in the parking was inefficient; managing on the fly.

Adding another product; Box of fish (10 pieces) nothing else. The margin are tight (approx. 20%) which doesn't include G&A which is approx. 10%.

215 online orders on the first night. 97 of them were drive through (done on site) \$883 in cash (no coins) collected the remainder were paid via credit card.

Action: (Tom C) Do we want to add a side of Frys to the menu? Potential to serve in a cup inside a bag.

Actions already taken:

Limiting online orders to 20 orders in a 15 minute window. Traffic flow will be changed; the online orders will come in from the Pontiac entrance. Parking lot divided into 4 rows and organized on Todoist for management. Sunday email sent to everyone who ordered online after the first week acknowledging logistical hiccups and offered a \$1 off for coupon for this Friday only.

Feedback from customers: need to separate the cold and hot food.

9 online sales already for Friday – 5 used the \$1 off coupon.
Nate: do we have the floor mates? Tom - Yes.
Thursday night prep – slaw and Salmon. Friday at noon – dropping shrimp.
